#### VIRTUAL ACADEMY COMPONENTS

Virtual Academy refers to a distance learning platform that is fully digital and online. Virtual Academy gives learners who are unable to attend school in a physical location for in-person education access to online educational materials prepared by assigned teacher(s) and allows teachers to provide instruction to students regardless of their location.

Students will have the opportunity to interact online (virtually) with their assigned teacher(s).

#### **RESTORE ILLINOIS PHASES**

The learning options provided <u>today</u> are in alignment with guidelines associated with Phase 4 of the Restore Illinois Plan. We ask for your continued patience during this time and acknowledgment that Plano CUSD #88 may need to move all students to Virtual Academy should the Governor of Illinois move our region into Phases 1-3.

Reasons which may require District 88 to move to fully Virtual Academy may include:

- Community or district experiences the spread of COVID-19
- The district has too many students ill/symptomatic/quarantining and is unable to host students
- The district has too many teachers or staff ill/symptomatic/quarantining and is unable to teach students
- The district has too many bus drivers ill/symptomatic/quarantining and is unable to transport students
