Notice is hereby given by the undersigned Clerk of Frenchtown School District No. 40, Missoula County, State of Montana that the Annual School Election will be held by mail ballot. Ballots will be counted on Tuesday, May 7, 2013 at the Elections Office at the Fairgrounds.

Electors will consider the following issues at the election:

- The Frenchtown Board of Trustees cancelled the trustee election, since the number of candidates filing a nomination petition or filing a declaration of intent to be a write-in candidate is equal to or less than the number of open trustee positions to be elected. Two candidates, Dianne M. Burke & David Weber, applied by the April 11th, 2013 deadline. They will be elected by acclamation at the Regular Board meeting in May 2013.
- Seek approval of additional levies in the amount of \$68,356.71 to minimize the reduction in staff and maintain a quality education.

Missoula County Election Administrator has determined that a mail ballot election conducted in accordance with the provisions of Title 13, Chapter 19, Parts 1-3, M.C.A. (the "Mail Ballot Act"), is in the best interests of the District and the electors thereof, and the Missoula County Election Administrator will prepare a mail ballot election plan in accordance with the provisions of Section 13-19-203, M.C.A.
