_____ 1. I understand that the enrollment fee must be paid to ensure that my child will have a position at Coosa Christian School for the 2021-2022 school year.

_____ 2. I understand that the enrollment/Re-enrollment fee is **not refundable** unless my child is denied admission at Coosa Christian School.

_____ 3. I understand that upon signing this contract, should my child be accepted for enrollment at Coosa Christian School for 2021-2022 School year, I am obligated to pay the full annual tuition to allow Coosa Christian School to meet financial obligations for salaries, services and products based on my intention.

_____ 4. I understand that tuition is billed as a yearly amount. Coosa Christian is allowing me to have the option to pay this over a 12 month period. If my account becomes delinquent at any time I am aware that CCS has the right to dismiss my child. A \$30.00 fee will be added for any returned checks.

_____ 5. Withdrawal: I agree that should I withdraw my child from Coosa Christian School at any time during the 2021-2022 school year, I will nevertheless fulfill my obligation in this contract to pay full tuition for the remainder of the school year.

_____ 6. I understand that I am financially responsible for damage to the school property (including Chromebooks) caused by my student. Cost of replacement for school issued chromebooks is \$200.

_____ 7. I understand that CCS retains the right to release any student who does not comply with the standards of CCS and/or The Church at Wills Creek or cooperate in the students education progression.
