

## **Barrington School Building Committee**

### **Meeting Minutes**

**June 2, 2022 3:45 p.m.**

**Barrington Middle School PD Room**

Present were Ms. Bae, Ms. Crean, Mr. Dwyer, Mr. Fiore, Mr. Glum, Mr. Messor, Dr. Rosengard, Mr. Sangiuliano, Mr. Valentine, and Mr. Wilmarth

Ms. Bae called the meeting to order at 3:51 p.m.

#### KBA Status Update

Presented by Mr. Schmigle, Ms. Jessup and Dr. Locker (virtually)

- Review of project timeline from Deep Dive Visioning sessions through Stage II submission
- Design team to present series of options (long term goals – over all 20-year plan) to Committee & Community – meeting to be scheduled tentative for middle of July
  - Meeting to include community members, School Committee, Town Council – possibility of live streaming meeting.
- Building committee will then need to meet again to vote on options presented – tentative for end of July
- Mr. Fiore asked if there was any update from RIDE regarding extension of bonuses
  - Ms. Jessup stated RIDE is still considering extension but should have information in July
- Design team to work on schematic design of option selected during summer months
- New Stage I submission (September 15) will include a supplemental report based on direction of long-term goals and will include executive summary, updated estimates of repair, etc.
- Design team to meet with school faculty, executive team, etc. to understand District's short-term 5-year plan for Stage II application Fall 2022
- Briefly discussed process for Stage II submission and deadline of February 15, 2023
- Vote needed by Committee at next meeting to approve new deadline of both Stage II and Supplemental Stage I submissions
- Dr. Locker is currently reviewing data collected from all Visioning sessions (community forums & deep dive)
  - Dr. Locker presented overview of Deep Dive visioning sessions
    - Approximately fifty attendees (educators, parents, student, design team, community representatives) met for two (2) days to work through a series of questions and challenges discussing future of education for overall master planning
  - Reviewed draft of press release to be sent out to community regarding results
