Construction Project Manager Report – Mike Marino

Mike Marino reported that Phase I of the project has been bid out and the Guaranteed Maximum Price (GMP) is on budget. The Architects are 75 percent complete with construction documents for Phase 2. Phase 2 will be sent out for bidding once it is finished. There was no opposition at the Conditional Use Permit (CUP) hearing. Findings are being developed by the planners for the final meeting that will be held on August 3, 2015 at 4:00 p.m. Mr. Marino expects mobilization can begin on Monday the following week [August 10th]. He recommended a ground breaking ceremony for the community. It was also noted that Wasco Electric is working on moving the power poles away from the building site location.

Superintendent Report – Wes Owens

Superintendent Owens began his report by thanking the board and several staff members for their work. He spoke on the temporary 4th grade position at Sherman Elementary, the K-12 music position, the licensed staff recall, and open coaching positions. He then presented a letter from Kirby Nagelhout explaining their last minute Construction Superintendent personnel change. He commented on his recent visit to a County Court Meeting on July 15th. Pictures of four water pipe leaks that have been found in the last few weeks were shown to the board. Craig Wood was thanked for repairing them. Jen Berry and Jeanie Pehlke attended an OSBA board secretary training and Kim McKinney attended the OASBO annual summer conference. Superintendent Owens then reported on locates and water volume tests. The Athletic Foundation, Dan Funkhouser and the Grass Valley Fire Department were thanked for their potential support of a project to replace the light bulbs on the track/football field complex. Superintendent Owens then discussed Fifth Grade Football safety. Finally he invited the board to a welcome back dinner that will take place on August 25, 2015.

Administrative Report for Jr./Sr. High School – Bill Blevins

Principal Blevins gave an update on teacher vacancies at the Jr./Sr. High School. He reported on a recent football safety clinic that he attended. This year, Mr. Blevins will be the mandatory “acting player safety coach” for the football program. He will also teach the other coaches and parents how to look for correct and incorrect tackling techniques. He then provided the high school volleyball and football camp and practice schedules. Finally, Mr. Blevins spoke to his ability to act as Athletic Director and High School Football Head Coach. He noted that without support of all board members he would not take on the position of High School Football Head Coach.

UNFINISHED BUSINESS

Approve and Sign CMGC Contract

Mike Marino presented the CMGC Contract for approval and signature. It was noted that Paul Taylor, an attorney who represents the District worked with Mike Marino and Kirby Nagelhout to develop the contract.

Motion by Vice Chair, Angie Thompson with second from Director, Kyle Blagg to approve the contract with KNCC as presented. **Vote:** 3 in Favor (Martin, Thompson, Blagg) 2 Opposed (Macnab, von Borstel) **Action:** The motion carried.

Chair Martin provided an opportunity for discussion related to the opposition votes. Director Macnab stated that it has been obvious where he has been coming from for a long time. There was no further discussion or comments.

Approve Guaranteed Maximum Price (GMP) for Phase I Construction

Mike Marino gave each board member a copy of the GMP spreadsheet that will become a part of the construction contract for Phase I. He noted that while the Phase I GMP came in higher than anticipated due to a late geo-tech discovery and kitchen equipment that was not included in the original estimate, it is still approximately \$7,000 under budget. It was noted that contingency funds of approximately \$77,000 and approximately \$80,000 in allowances for utility work will roll into Phase 2 if not needed for Phase I.

Motion by Director, Kyle Blagg with second from Vice Chair, Angie Thompson to approve and execute the guaranteed maximum price for phase one construction in the amount of \$3,061,017.00. **Vote:** 3 in Favor (Martin, Thompson, Blagg) 2 Opposed (Macnab, von Borstel) **Action:** The motion carried.

Approve Hire of Bill Blevins – Athletic Director

Superintendent Owens stated that this will be the fourth time since 2005 that this position has been filled by a Principal in this dual role. Superintendent Owens highly recommended Bill Blevins for the position of Athletic Director, stating he has full faith in Mr. Blevins' background and abilities to perform all of the duties. He further noted that Mr. Blevins is a perfect fit and explained that in small school environments it is necessary for staff to perform multiple roles. Director Macnab made the comment that he hired a Principal, not someone who does multiple jobs. Superintendent Owens reiterated that this will be the fourth Principal since 2005 to perform the dual role and stated again that it will be difficult to find a better person to fill the position. Chair Martin reminded Director Macnab that he didn't support the Athletic Director hire last year and emphasized the need for the Athletic Director to be in the District every day. Chair Martin further stated that it is not financially possible to hire just an Athletic Director and if we want to do what is best for kids then the Athletic Director must be on staff and perform dual roles. Chair Martin highly praised Mr. Blevins' organizational and coaching skills.

Motion by Director, Kyle Blagg with second from Vice Chair, Angie Thompson to Approve the hire of Bill Blevins as the Athletic Director. **Vote:** 4 in Favor (Martin, Thompson, Blagg, von Borstel) 1 Opposed (Macnab) **Action:** The motion carried.

Approve Hire of Bill Blevins – High School Football Head Coach

Superintendent Owens spoke highly of and recommended Bill Blevins as head football coach, stating that he is the best fit with his extensive coaching and playing experience. In addition, Mr. Blevins has the support of the entire football program coaching staff. Superintendent Owens reminded the board that Mr. Blevins, on his own, attended the football safety clinic. He also noted that no other applications for the position have been received. Director Blagg stressed the

importance of having the head football coach on staff and at school so they are available to parents, teachers and other staff. Director Macnab reiterated his comment that he hired a Principal and his number one job is to be the Principal and he should not coach or be the Athletic Director. Superintendent Owens stated that you cannot find a better connection with kids than through coaching and our young men will benefit from his leadership. He further stated that we are here first and foremost to teach kids academics but many valuable lessons are learned on the athletic fields and athletic courts. Superintendent Owens again stated that without hesitation he recommends Bill Blevins as the High School Football Head Coach. Director Macnab clarified that he believes no one can effectively run the school and do all the other jobs we ask them to do. Chair Martin asked Director Macnab if he believes that not having a football program is best for kids. Director Macnab stated that the most important thing for us to do is educate the kids and the football program is not important to him. Director Macnab reiterated his statement that he hired a Principal and wants a Principal fulltime. Mr. Blevins noted that Dr. Tarzian shared with him that he felt the same way, but after visiting three of Mr. Blevins' practices he changed his mind. Dr. Tarzian told Mr. Blevins that he could see that through coaching, connections are made with the kids and it affects them the rest of the school day, not just during practice. Dr. Tarzian encouraged Mr. Blevins to continue to coach. Director von Borstel then asked Mr. Blevins if he felt his coaching in anyway takes away from any part of his job as Principal. Mr. Blevins noted that the football coaching staff is very experienced and his family is accustomed to his coaching duties that take place in the evening. Mr. Blevins stated that this will not affect the safety of the students, as it didn't during basketball season. Director von Borstel stated that she understands in small schools people have to wear dual hats and wondered which Mr. Blevins would pick first, Principal or Athletic Director. Mr. Blevins chose Principal. Superintendent Owens added that he will be relieving Mr. Blevins of the evaluation of teachers at Sherman Elementary. Superintendent Owens then spoke to the safety of kids related to administrators who coach. He reflected on past administrative experience. Having an administrator coach provides additional safety for students because there is often an administrator on the campus late into the evening.

With the amount of the loan potentially reaching the 5 million dollar level, the Court feels the need to clearly state our position to the School Board.
