Called to Order

The work session was called to order at 3:04pm by Liz Mills.

Architect Presentations

The top three architects from the RFP gave presentations to the selection committee. Project Manager Mike Marino started the presentations by explaining the format to the presenting architect.

BBT Architects – Rene from the firm handed out a Proposed Work Plan and Information Booklet. Rene Alexander, Todd Turner, and Dan Pyle each gave their history and experience with the firm. The firm was established in 1976 and is experienced in rural communities. They also have local experience as they were involved with Sherman Elementary School and the gym addition at the Sherman High School. Rene briefly discussed the hand outs and display boards they presented.

The interview questions were then asked by the committee.

Rene from the firm asked what each committee member hoped to see as a result of the consolidation. Most members agreed that they hope to have a better sense of community by consolidating and look forward to improved safety and modernization.

BLRB Architects – Tom Stark, Mike, and Greg represented the firm. Each of them gave their experience and role with the firm. They have recent experience in K-12 campus construction. 90% of their experience is in K-12 campus construction. The firm has been in existence for 61 years. Greg discussed their process and explained the display boards they presented. He gave details and explanation of their conceptual design which was based around 21st century best learning practices, organized by grade groups and based around learning centers.

The interview questions were then asked by the committee.

Todd discussed the project schedule a little more in depth.

Steele Associates – Scott Steele, Jeff Wellman, Steve Olson, and Emily Freed represented the firm. Each of them gave their experience and role with the firm. An element that sets their firm apart is they have sub consultants that have worked with them on all of their projects for many years and they have a core group that has been together for 8 years. They also have local knowledge as they have already been working with the district and would give them a head start on the project. Scott made clear that the conceptual designs that have been done for the school are not final. The firm will use what they already know to work with the design committee to create a design that will work for the district.

The interview questions were then asked by the committee.

Scott discussed the conceptual design. He discussed a roofing issue that came up when checking references. Scott explained the presentation boards they displayed.

Mike Marino discussed with the committee the next steps. They adjourned at 6:03p.m.
