Notice of Proposed Action to Hold a Public Hearing on the Issuance of School Infrastructure Sales, Services, and Use Tax Revenue Refunding Bonds in a Principal Amount Not to Exceed \$2,100,000.

The Board of Directors (the "Board) of the Danville Community School District (the "School District"), will meet in person on the 9th day of November, 2020, in Classroom 217: 21st Century Classroom, 419 S Main Street, Danville, Iowa at 5:30pm for the purpose of instituting proceedings and taking action to issue not to exceed \$2,100,000 school infrastructure sales, services, and use tax revenue refunding bonds, in one or more series (the "bonds"), for the purpose of (1) refunding the School District's outstanding School Infrastructure Sales, Services, and Use Tax Revenue Bonds, Series 2012; and (2) paying related costs of issuance.

The Bonds, when issued, will be payable from the State Secure an Advanced Vision for Education Fund revenues and will <u>not</u> be payable from property taxes.

At such time and place the Board shall receive oral or written objections from any resident or property owner of the School District. If written comments are sent electronically, they should be emailed by 4:00 p.m. on November 9th, 2020 to <u>Janelle.schneiderman@danvillecsd.org</u> and will be presented at the public hearing and recorded in the minutes thereof.

At any time prior to the date of the public hearing or within fourteen days after the date of the public hearing, a petition may be filed with the School District asking that the questions of issuing the Bonds be submitted to the registered voters of the School District, pursuant to the provisions of Section 423F.4 of the Iowa Code. If no such petition is filed, the Board may determine to issue the Bonds, in which case, the decision will be final unless appealed to the District Court within fourteen (14) days from the date of the hearing. If a legally sufficient petition calling for an election is filed with the School District, the School District may determine not to issue the Bonds or may submit the question at an election as provided by Iowa law.
