4. SCHOOL PRIDE RECOGNITION

A. Blytheville Intermediate School students performed excerpts from their Black History Program, which will be held on Friday, February 26. Felicia Dotson is the director of the program.

- 5. INFORMATION ITEMS AND REPORTS
  - A. Superintendent's Report
    - 1. Charlotte Razer, CPA from Thomas, Speight and Noble, presented the 2008-2009 audit report to the Board. She outlined the information in the audit and stated that the audit showed that the district was in compliance with state statutes.

- 2. Superintendent Atwill welcomed members of the Greater Blytheville Area Chamber of Commerce and the Blytheville Leadership Institute.
- A district safety and crisis plan is being developed and will be presented to the Board for approval at the March Board of Education meeting.
- 4. An ACSIP monitoring visit is scheduled for March 2.
- 5. A Standards Assurance monitoring visit is scheduled for March 4. It was rescheduled from February 9 due to inclement weather.
- Superintendent Atwill recently met with German Cura, Managing Director of North America Operations for Tenaris. They are tailoring a proposal of involvement for the community and schools.
- 7. The third State of the School Address was held on February 18 at the Ritz Civic Center. One of the concerns voiced during the address was the small number of African American teachers employed by the district. The district will work with the local chapter of the NAACP to help recruit quality teachers of all races. Parent/community questionnaires were distributed during the address. The results will be shared with the Board.

- 1. The canopies for Blytheville Primary School have been bid. Work will begin during spring break.
- 2. Fire alarms for Blytheville Intermediate School will be bid tomorrow.
- 3. Fire alarms will soon be bid for the T&I and band buildings at Blytheville High School.
- 4. Contractors are working on the roof and removing windows at Blytheville Charter School. The boiler quit working, so modifications had to be made and heating units had to be placed on tables.
- 5. A soup/chili line has been added in the Blytheville High School Cafeteria to go along with the regular lunch tray. Portion sizes were increased at the secondary schools. Meals are being improved.

- 6. The canopy and concrete playground at Central Elementary School will be done after school is out.
- 7. Vice President Hixson commended the staff for doing a great job removing snow from driveways and parking lots.
