The Vice President called the meeting to order and established a guorum with six (6) members present.

# **APPROVAL OF MINUTES**

The Board approved minutes of the meetings of January 21, February 4, and February 11, 2014 were approved as presented.

### **REVISION OF AGENDA**

Mr. Donnie Whitten, Superintendent, requested the addition of an agenda item - 6C-6: "Consideration of Partnership Program Resolution." A motion to approve addition of the agenda item was made by Dr. Motl, seconded by Mr. Turner, and carried 6-0.

# REPORT OF EXCELLENCE

Ms. Jeanette Turner, Director of Curriculum and Instruction, led in honoring grant recipients recently selected by the Ross Foundation to receive project funding for use in various educational activity proposals. Those honored were Ms. Charlotte Dewitt, Ms. Jane Watson, and Ms. Patti Goodson.

# **INSTRUCTIONAL REPORT**

Mr. Whitten introduced L.M. Goza Principal, Ms. Angela Garner, math faculty members – Jeremy Smith, Misty Smith, and Sarah Moss, as well as several students, for a demonstration of instructional methods illustrating the transition to Common Core from Arkansas Frameworks.

#### FINANCIAL STATEMENT

The Board and Superintendent reviewed the District's financial statements.

## **COMMUNICATIONS UPDATE**

Mr. Sean Ruggles, Director of Communications, presented an update on the progress of the District's communication system. Mr. Ruggles introduced the construction of a district smart phone Ap , as well as information on extensive updating of the District web page. A press release announcing completion of the projects will inform the staff of completion of these projects in the near future.

# PRESENTATION: JOBS FOR CLARK COUNTY - ECONOMIC DEVELOPMENT TAX

The Superintendent introduced Mr. Bill Wright, member of the Board of Directors of The Economic Development Corporation of Clark County, who provided information concerning the importance of continuing the Economic Development tax, to be voted on by citizens of Clark County during a special election to be conducted on March 11.

Mr. Henry Wilson, member of the audience, addressed Mr. Wright, with a question regarding small business owners' benefits from the tax. Mr. Wright responded to the question, and the need to focus on that issue.

# **ARKADELPHIA PROMISE UPDATE.**

Mr. Jason Jones, Director of the Arkadelphia Promise Scholarship program, provided an update on the

program that is funded by Southern Bancorp and the Ross Foundation, showing data and student college retention rates resulting from the benefits of the program.

# ARKANSAS RICE DEPOT - WELLNESS COMMITTEE REPORT

An update on the Arkansas Wellness Committee and partnership with the Arkansas Rice Depot was presented by Dr. Virginia Anderson. The program is coordinated through the counseling departments of all five schools in assuring that students needing nutritional/health assistance are serviced. There was discussion of board involvement in meeting health and nutritional needs of students. Mr. Whitten spoke on behalf of the Board's desire to assist in any way(s) that might be needed.
