## ARKADELPHIA BOARD OF EDUCATION OFFICIAL MINUTES: NOVEMBER 19, 2013

The Arkadelphia Board of Education met in regular session Tuesday, November 19, 2013 at 6 p.m. in the Boardroom of the Administration Building, located at 235 North Eleventh Street.

### Approval of Minutes

A motion was made by Dr. Harris, seconded by Mr. Randy Turner, and carried 7-0 to approve the minutes of the Special Meeting of November 5, 2013, with correction on the time of adjournment of the meeting to 6:12 p.m. The October 15, 2013 minutes were approved as presented.

#### **Report of Excellence/ Instructional Report**

Mrs. Jeanette Turner, Director of Curriculum and Instruction, introduced Mrs. Nikki Thomas, Peake Principal, Ms. Lara Veazey and Mrs. Tori Rocole, 5<sup>th</sup> grade teachers, for an update on use of iPads in the Peake classrooms.

Mrs. Veazey presented information on the use of iPads in the classrooms, and reported that students recently completed an Ecosystem project using the iPads. Several students shared experience with the project. Mrs. Tori Rocole spoke to the Board about a recent opportunity to use Skype for the students to speak with a class in Texas.
