# Riverview Special School Board Meeting December 8, 2016 Riverview Administration Building 7:00 p.m.

Robyn Roach opened the meeting with prayer.

The meeting was called to order by Vice President, Shane Sellers, at 7:00 pm.

### Student Hearing - Student A - ID #2926

Mr. Rutledge presented student A- ID #2926 for student hearing due to violation of handbook policy of possession of over the counter and prescription drugs (Tramadol and Coricidin/Triple Cs) on campus. Mr. Rutledge did asked the parent of student A-ID #2926 if they would like a close hearing or an open hearing. The parent chose an open hearing. At 8:03 pm, JoAnn Coyle made the motion to add Action Item #3 – Approve Nabholz Construction Services to Contract With Building & Earth Sciences, Inc. to Provide Construction Materials Testing and Special Inspection Services for the Riverview High School Auditorium to the board agenda. Second by Scotty Andrews. Motion carried, 6-0.

### Action Item #1-Consider the Repair of Bus #13-7-11 With the Cost Not to Exceed \$19,500.00 From Summit Truck Group

Mr. Rutledge presented to the board the attached estimate from Summit Truck Group to repair Bus #13-7-11 due to the damage of a bent camshaft that in turn damaged other portions of the engine. The attached Summit Truck Group estimate says \$19, 275.15 but that was before the company shared there may be a few addition harnesses, etc. that would push the price up a bit. Mr. Rutledge recommended to the board to approve the repair of \$19,500.00 for the bus. At 8:08 pm, Robyn Roach made the motion to approve the \$19,500.00 to repair bus #13-7-11 from Summit Truck Group, second by Shane Sellers. Motion carried, 6-0.

### Action Item #2 – Consider the Purchase of a 2015 Blue Bird, 71 Passenger Conventional Vision Bus From Central Bus Sales for \$71,500.00

In order to get a second bus needed in the fleet, Mr. Rutledge recommended to the board to purchase the 2015 Blue Bird Conventional Vision Bus from Central Bus Sales for \$71,500.00. The bus is an off-lease bus with approximately 27, 000 miles. The bus carries a bumper-to-bumper warranty for one year and an extended warranty for two additional years. Also, the specs on this bus are very similar to what we would use as our specs if we were to purchase a new bus. We can have this bus in the fleet by the start of the school in January 2017. At 8:15 pm, motion was made by Scotty Andrews to purchase the 2015 Blue Bird Conventional Vision Bus from Central Bus Sales for \$71,500.00. Second by Josh Havener. Motion carried, 6-0.
