## Teaching and Learning:

• Teacher Leader Evaluation— The State Department is now rushing us to complete a plan to be ready for the 2015-16 school year, and rushing our teachers to complete a component of the Teacher Evaluation program that will require hours of training and time to complete. We hope that we will receive more clarifications on what is actually required very soon, but we do not have to meet a December 1 timeline that was imposed just last week and is now just a suggestion. Regardless, we still must deal with this issue that accounts for 35% of a Teacher's Evaluation (about 85% of our teachers would have to complete this process called SLO or SOO since they would not have student test scores from State Testing). I will keep you updated on the process as we learn more about it as well.

The planning and continued follow-up for these past years for transitioning students, staff and materials, equipment and then surplusing the rest have been tasks shared by many but coordinated by Dr. Twidwell and her Operations Team.
