# Mr. Munn offered the following:

- ✓ Much time has been spent on Informal Observations, Professional Learning Plans and Student Learning Objectives meetings. Currently we have been working on Data Chats reviewing informal assessments with staff. This has been a learning experience for everyone! These professional discussions have led to numerous suggestions for instructional practice and a focus on exit outcomes.
- ✓ Committee on Special Education/Section 504/CPSE annual review meetings are beginning and meetings will be held three days a month starting in January. Every students program is reviewed on an annual basis.
- ✓ This year we continue to have a few students in our UPK Program receiving services under CPSE. Services are provided to students who qualify as a pull out or a push in service. Providing students with early intervention services helps to prepare students for the transition into kindergarten and often these students are declassified at an early age in school.
- ✓ The musical "Back to the 80's" was well attended and was enjoyed by many. The kids did an awesome job!
- ✓ Changes in student's lunches have led to increased lines this year. Teachers are adjusting their schedules to spend up to 10 additional minutes supervising in the cafeteria to make sure students have time to eat.
- ✓ A representative from VESID, which is now called ACCESS-VR, which stands for Adult Career and Continuing Education Services Vocational Rehabilitation, will be meeting with some of our seniors beginning in December. Students and their parents are invited to meet with a counselor and discuss their future plans and are often able to assist with tutoring, job coaches, and equipment and in some cases college tuition assistance. Services are at no cost to the families. ACCESS-VR continues to work with our graduates once they leave school.
