### K-12 PRINCIPAL'S REPORT:

Mrs. O'Shaughnessy offered the following report:

### **Student Highlights:**

- ✓ Parent guides to the Common Core from the materials provided by EngageNY were sent home with interim reports after a call home informing parents what was coming.
- ✓ All students in grades 6-8 and grades 10-12 now have and school issued email. 9<sup>th</sup> grade will be brought on board as 10<sup>th</sup> graders next year when they have iPads and a need for email in CFM.
- ✓ The Seniors vs. Faculty basketball game was great fun for all. A parent comment after it was over was that we "should do this more often."
- ✓ OWN Energy is working on a contest exclusively for CCS students whereby they design the logo for the current wind turbine project. There will be seven winners, two at each level plus a grand prize winner.
- ✓ A meeting was held with the math teachers to discuss acceleration. Since the Common Core is written as such, we will attempt to start acceleration in 7<sup>th</sup> grade next year.

#### Administrative Highlights:

- ✓ CCS will be hosting the next round of Common Core training sessions. All teachers of math and ELA will be in attendance.
- ✓ Plans to move our student management system to NERIC from the MORIC are going much more smoothly than we could have hoped.
- ✓ Karen Reed has been selected as teacher of the year by the VFW at the local, district and state levels.
- ✓ Second round observations are nearly completed for the year.
- ✓ The Teacher Center Ellison machine is now housed at CCS.
- ✓ Our RTTT work day consisted of ELA teachers meeting with those in grades above and below them to determine gaps that have occurred due to Common Core implementation and how to fill those gaps. All other teachers participated in two training sessions, one regarding vocabulary and one regarding literacy in the non-ELA classroom.
- ✓ Almost all teachers of grades 9-10 have received initial training for their iPads in preparation for next year. Only one teacher has yet to receive this first level of training.
- ✓ The last round of Data chats start tomorrow.

### **DIRECTOR OF STUDENT SERVICES:**

Mr. Munn offered the following report:

- ✓ We have been honored to participate on behalf of the Community Broadcasters, a group of radio stations in Watertown in particular The Eagle on 100.7, by having our pre-K through third grade students saying the Pledge of Allegiance on the radio. The radio station informed us ahead of time when their message would be aired so we could listen.
- ✓ Students in UPK 5 are participating in a "School Plastic Bag Recycling Challenge" program sponsored by Cooperative Extension of Jefferson County. There are prizes for the top three classrooms that collect the most plastic bags. Students will learn the importance of recycling.

- ✓ Letters have been mailed to parents of incoming UPK and Kindergarten students. We have 31 possible prekers and 7 out of district prekers who have requested attendance in our program. Kindergarten has 41 students as of this date.
- ✓ Field guidance from NYSED recommends that we prepare others for significant decreases in pass rates on 3-8 testing as a result of the new tests and new standards. Clarification related to how these scores would impact teacher and principal growth scores were discussed in order to ease fears that NYS was setting teachers and principals up for failure. They explain, with some complex math, that no teachers or principals should be hurt in the making of these growth scores. Furthermore, no new schools will be identified as Focus Districts and no new schools will be identified as Priority Schools based on 2012-13 assessment results
- ✓ The Elementary schedule is in draft form for the 13-14 school year as scheduling for the middle and high school will begin soon.
- ✓ Parent Conferences were successfully held for UPK students.
- ✓ Elementary observations have been completed. Non-tenured teachers receive two observations a year and will be completed in April.

### **SUPERINTENDENT'S REPORT:**

Mr. Connell reported the message/music heard by the public when they call in and are placed on hold is our elementary students reciting the Pledge of Allegiance. At Christmas time the public heard elementary students singing Christmas songs. We will continue to change what people hear.

<u>Budget</u> – With regard to the Budget, the New York State legislature will vote on their budget on March 28<sup>th</sup>. District Treasurer Marcia Mundy advised the Board she recently went through Copenhagen's proposed budget, line by line, and she feels we are now looking at an \$80,000.00 gap. She advised she is anxiously awaiting the State Aid runs. She also noted the district has pared down a lot in the last three to four years and she thinks the District will be okay with a 2.9% tax increase.

<u>Wind Farm</u> – Mr. Connell noted stakeholders are still in negotiation with OWN Energy. OWN has completed the environmental study and they hope to have the wind farm up and running by the spring of 2015.
