Student Highlights:

- Our students were strong competitors at the annual Lewis County Fair Spelling Bees. At all grade levels CCS placed in the top five which were the monetary winners.
- The visitors from Carthage who attended last month's meeting contacted us the next day with a heartfelt "thank you" for allowing their students to participate in our process.
- The summer online health class proved to run much more smoothly this year. Students were all very successful in the course.
- The annual DL demo and mandatory meeting was held this week in preparation for the beginning of classes next week.

Administrative Highlights:

The learning curve for us to implement full compliance with the CR Part 154 regulations for ELLs continues to be steep, but baby steps are being accomplished.

- After much conversation and consultation, eSD was used to successfully complete the VADIR report.
- Summer work on the K-12 writing curriculum was a great experience for all who attended. Work will continue throughout the year.
- Administrators have been recertified to be teacher evaluators. Unfortunately, conflicting information continues to confuse matters regarding the new regulations.
- Data Boot Camp at Adirondack Middle School provided many useful reports that will be used as tools for content meetings in September and October.

ASSISTANT PRINCIPAL'S REPORT:

Mrs. Ratliff thanked the Board for supporting the Summer Learning Program which has ended for another year and was very successful. Data results were included with her report. A special thank you goes out to Sydney O'Shaughnessy for her lessons on gardening, nutrition and the environment. More information on the gardening project can be found on her blog.

- The Consolidated Application for Title I funding has been submitted, as has a proposal for the 2015-2016 Expanded Day Prekindergarten Grant. Funding has also been secured for a professional learning community through the Jeff-Lewis Teacher Center.
- The Elementary Student Handbook has been updated, and the CCS Code of Conduct was replaced with a "Kid Friendly" version per state regulations.
- Third grade orientation is new this year and has been designed to alleviate some of the questions and concerns parents may have regarding this next step in their child's education. Topics such as the switch from learning to read to reading to learn, classroom expectations and NYS Tests will be discussed.
- Data Boot Camp, Day 2 took place at Adirondack Middle School. This time was spent delving into the data of the 3-8 tests and discussing building wide data
- Over the summer, more than 20 students enrolled in grades K-5. This has forced us to change classroom and teacher assignments as a way to provide the best learning environment for all students. The flexibility and hard work of teachers and the custodial staff is greatly appreciated!
- Safe Schools has received the updated version of our Building Wide Safety Plan. The plan was molded into the Emergency Response Plan Template provided by Safe Schools as a way to satisfy state regulations and is consistent with national preparedness guidelines.

SUPERINTENDENT'S REPORT:

Mr. Connell noted the elimination of one bus route did not occur as one of the parochial runs was adjusted. We did lose one driver, but kept all routes. He also talked the about 3rd grade numbers growing and the need for a second section with an influx of 28 new students K-5. The elementary has again been restructured. Interviews were completed for the .5 FTE Health/PE position. Sarah Jolliff was the successful candidate. Mr. Kilionski was a positive influence in the District and we wish him well in his new position. The application for Smart Schools Bond Act which has consumed much of Mrs. Rowsam's time has been submitted. Mr. Connell attended an APPR meeting with another scheduled for November 15. He anticipates applying for a waiver with regard to the new APPR. The new Spanish speaking student from Mexico most likely will be going to Watertown High School. It is anticipated they have the appropriate classes for him. On September 14th, Mr. Connell will participate in a Lewis County job fair with other Lewis County Schools. Fall practices are under way. We will be cutting JV Girls Soccer due to low numbers. Board Goals will be addressed at the September Work Session.
