PRINCIPAL'S REPORT:

Mrs. Nadine O'Shaughnessy offered the following:

Student Highlights:

- Our partnership with BOCES and Sackets Harbor Central School to provide ESOL support for our ELLs started out a little confusing, but is now running like clockwork. Both the RBERN and Migrant Tutor Program have been here to check on our progress and were happy with what they found.
- Tenth graders took their ACT ASPIRE test online for the second year in a row. The administrative preparation for the test is worth the ease with which the students are able to take it.
- The summer reading challenge party was great fun for all students who participated.
- Starting this month, schools are now required to provide hands-only CPR instruction to high school students. Mr. Randall will incorporate that into his PE classes.
- Pink Week was a huge success. Participation in events was enthusiastic.
- The Student Council Blood Drive met the goal the group set.

Administrative Highlights:

- Another plan that is now mandated for schools to create is a "P-12 Counseling Plan" which also requires a P-12 Counseling Advisory Council. Our guidance counselors are keeping us compliant.
- All BEDS data has been collected. Verification will occur over the next couple of weeks for submission by deadline.
- The evacuation drill, by all accounts and feedback so far, was one of the smoothest we've had. From lockdown in school to busses pulling out from the upper garage, the entire process took just over thirty minutes.
- Grades 3-12 teachers have looked at local and regional state assessment data to determine areas of concern in terms of how CCS students performed compared to their same age peers. Trends were identified and will be considered in preparation for this year's exams.
- The first round of informal observations has been completed and formal observations have begun.
- The state mandated "Former ELL" plan has been completed and submitted.
- Thank you to the Board for budgeting our presenter for our staff development half day, Willow Sweeney, was amazing and just what the doctor ordered.
- Mrs. O'Shaughnessy thanked the Board for its support of administration and allowing them to do their jobs.
