## **DIRECTOR OF STUDENT SERVICES:** Mr. Munn offered the following:

- ✓ The Lewis County Sheriff's Department expects that the DARE program will continue through this school year. They are unsure if they will continue to have the resources to fund the program the following year.
- ✓ Kindergarten enrollment continues to rise. It is now the largest cohort in the Elementary school with 42 students.
- ✓ First Grade Enrichment class performed 2 songs for the Kindergarteners, including "Silent E" and "I Can Sing my Alphabet Backwards and Forwards." There are several other examples of our older students stepping into the class of younger students to assist them.
- ✓ PTO elections have taken place. Attendance at the recent meeting was up significantly and many appear willing to volunteer. The meeting was productive and helped lead to a successful "Evening with Santa." Nearly 300 items were collected for the food pantry and all funds from vendors tables were donated to the pantry as well.
- ✓ NYS Special education annual data forms have been submitted. Increased number of identified students on BEDS day can mostly be attributed to population variables. Many more SWD's have entered the district then exited.
- ✓ Scrubby Bears have completed most of their sessions with UPK-2<sup>nd</sup> grade students. It appears to be beneficial to both our High School and Primary students develop necessary skills for the real world.
