- RTI data to support student learning objectives. Data from Kindergarten demonstrates individual student growth, but a decline in overall exit outcomes from last year. This may be attributed to class size.
- ✓ Planning has begun for the Summer Learning Program. It will be nice to see kids in the building this summer. The Summer Recreation Program sponsored by the village will also resume this year.
- ✓ Our Community Garden is underway. Donations have been received to support the construction process. Students will be taking an active role in the process.

### **SUPERINTENDENT'S REPORT:**

2012-2013 Budget has passed and Mr. Connell noted he thought the Town Hall Meeting helped. Mrs. Mundy has worked out preliminary figures with regard to savings to the District is enjoying because of the geothermal project. Mr. Connell has been in contact with Laura Payne Bourcy with regard to grants and it looks like the available grants are beyond the District's reach. With regard to the APPR Rubric, Mr. Connell is in favor of using the NYSUT Rubric. He said three other districts, Indian River, Lyme and South Jefferson are also looking at the NYSUT Mr. Connell also discussed the Jefferson-Lewis School Boards Dessert Rubric. Workshop he attended with regard to shared services. Mrs. Beverly Ouderkirk, shared Superintendent of the Brushton Moira Central School and St. Regis Falls Central Schools Districts was the speaker who discussed the pros and cons which have been perceived in the past two years of these districts sharing a Superintendent. Mr. Connell noted another windmill meeting has been conducted wherein he learned 85% of the landowners have signed on. The Community Committee has also met again. The Clinic is at a standstill at this point and the One-on-one i-Pad Initiative will be launched. The i-Pad Learners Road Show will be here on July 24th. The District has received 69 elementary applications and 10 math allocations. The plan is to schedule interviews on or around June 5.
