

# Georgia Special Needs Scholarship Program Continuing Participation 2014 – 2015 School Year

This document is for a parent/guardian whose child(ren) participated in the Georgia Special Needs Scholarship (GSNS) Program during the 2013 - 2014 school year and completed the school year in an authorized private school. The web page for the program is the primary method used to share information regarding the GSNS Program and a parent/guardian is responsible for reading the information provided.

IMPORTANT: Due to funding, a student that attended an authorized private school for the 2013 - 2014 school year, but did not complete the year at the private school is ineligible to participate in the GSNS Program for the 2014 – 2015 school year. The only way a student can re-qualify for the Georgia Special Needs Scholarship Program is to again meet the program requirements outlined in law. A student can regain eligibility for the 2015 - 2016 school year if a student is enrolled and reported by a public school system or school systems for funding purposes during the October 2014 AND March 2015 full-time equivalent (FTE) program counts during the 2014 - 2015 school year. In addition, the student must be reported as a special needs student served by an active IEP through the FTE reporting system.

### PARENTS/GUARDIANS ARE RESPONSIBLE FOR ENROLLING THEIR CHILDREN IN AUTHORIZED PRIVATE SCHOOLS

The calculator with new award amounts for the 2014 - 2015 school year will be available in May 2014. **IMPORTANT:** A parent will need to enter the last public school a student attended, not the private school the student attends to have the calculator work correctly.

A parent/guardian is required to provide a private school with a copy of the new 2014 – 2015 scholarship award sheet for the student. This notifies a private school that a student is still eligible for the GSNS Program and what his/her award amount will be for the new school year. The award sheet is the only document needed by a parent/guardian for proof of a student's eligibility for the GSNS Program and notifies a private school that a student is still eligible for the GSNS Program.

Authorized private schools have access to an electronic system which they use to report eligible students enrolled at their schools to the GaDOE. Each school year private schools report enrolled students, so the GaDOE knows which students are participating in the private school choice option and where they are enrolled. Without notification of a student's continued eligibility, the private school will not report the student as enrolled in the GSNS Program to the GaDOE. This will affect the scholarship payments for a student and could affect his/her eligibility for the GSNS Program.

A parent/guardian re-enrolling a student in the same private school for the 2014 – 2015 school year must follow the re-enrollment procedures in place at the private school.

## Georgia Special Needs Scholarship Program Continuing Participation 2014 – 2015 School Year

A parent/guardian enrolling a student in a new private school for the 2014 – 2015 school year will need to contact a private school directly about its admissions procedures. The scholarship can only be used at a private school authorized to participate in the GSNS Program. The list of authorized private schools with contact information is posted on the GSNS Program web page and will be updated through August 2014.

#### **Understanding Special Needs Scholarship Award Amounts for Continuing Students**

Scholarship award amounts are not fixed from school year to school year. Scholarship awards for returning GSNS students are calculated using the data from the last year a student was in a Georgia public school. The data is entered into the state public education funding formula that applies to the new school year. As with all state funded programs, scholarships actually paid are dependent on appropriations made by the Georgia General Assembly.

A private school participating in the GSNS Program is not required to alter any of its business practices or policies under the Special Needs Scholarship Program. Therefore, a parent/guardian is responsible for complying with the private school's business practices and policies.

A parent/guardian must read and understand any contracts/agreements entered into with a private school. A parent/guardian must obtain written copies of any contracts/agreements entered with the school (e.g. tuition reimbursement, fee schedules). Parent/guardian must keep track of any payments made to a private school. GaDOE staff **cannot** resolve any disputes that may arise between a parent/guardian and a private school.

#### GSNS funds cannot be used to pay for the following:

- × Transportation
- × Before or after school care
- × Meals
- × Tutoring
- × Field trip fees

- × Athletic fees
- × School supplies
- × Summer school/camp programs
- × Other fees as determined by the GaDOE.



## Georgia Special Needs Scholarship Program For Students Continuing in the Program 2014 – 2015 School Year

#### MAINTAINING ELIGIBILITY

Important: A student must complete the 2014 - 2015 school year at an authorized private school to continue in the private school choice option for the 2015 - 2016 school year. Due to funding, a student that attends an authorized private school for the 2014 - 2015 school year, but does not complete the year at an authorized private school is ineligible to participate in the GSNS Program for the 2015 – 2016 school year. The only way a student can re-qualify for the Georgia Special Needs Scholarship Program is to again meet the program requirements outlined in law.

A student may continue to participate in the GSNS Program as long as:

- ✓ Student remains a resident of Georgia; and
- ✓ Student's parent/guardian remain residents of Georgia; and
- ✓ Student has continual enrollment and attendance in a private school participating in the GSNS Program; and
- ✓ Parent/guardian complies with GSNS Program law and rule.

An IEP does not need to be kept current to continue a student's participation in the GSNS Program.

Promotion or retention of a student **does not** affect eligibility for the GSNS Program.

Eligibility for the GSNS Program ends if:

- ✓ A student leaves an authorized private school and does not re-enroll in another authorized private school. OR
- ✓ A student graduates from high school. OR
- ✓ If a student turns 21 years old and has not yet graduated from high school.
