APPROVAL OF MINUTES

Ms. Thomas presented highlights of creative academic programs the school has implemented for students during the 2012-13 year.

HEARING OF INDIVIDUALS AND DELEGATIONS

The Board was addressed by Ms. Julie Bradshaw regarding the subject of concurrent college course grades being weighted on the 5.0 GPA scale.

BID CONSIDERATION COMPUTERS FOR NEW TECH PROGRAM

Upon the recommendation of the Superintendent, a motion was made by Dr. Perrin, seconded by Dr. Harris, and carried 7-0 to approve the bid of **CDI Computer Dealers**, Inc. for the purchase of 168 laptop computers for the AHS NewTech program for 2013/14 @ \$101,308.62. Upon the recommendation of the Superintendent, a motion was made by Dr. Harris, seconded by Mr. Groom, and carried 7-0 to approve the bid of Partstock for the purchase of sixty (60) Dell Optiplex 7010 desktop computers to replace teacher workstations at Perritt, Central, and Peake schools @ a total of \$34,828.50. Other bids received were: **GovConnection**: \$34,905.97 and ITSavvy: \$35,203.48

BID CONSIDERATION COWS FOR GOZA MIDDLE SCHOOL

Upon the recommendation of the Superintendent, a motion was made by Ms. King, seconded by Dr. Harris, and carried 7-0 to approve the single source bid of GovConnection for purchase of thirty (30) latitude laptops and movable storage cart to be used in the sixth grade wing of Goza Middle School @\$21,951.56.
