1. CALL TO ORDER President Bennett called the regular meeting for the month of

October 2011 to order.

2. ESTABLISHMENT OF

4. SCHOOL PRIDE RECOGNITION

Ann Lewis, Principal of Blytheville Charter School/ALC, introduced Kim Byrd. Ms. Byrd introduced the students from the Food Production Class who prepared the meal for the Board.

5. INFORMATION ITEMS AND REPORTS

A. Superintendent's Report

- The town hall meetings have been held in several locations, with only a few in attendance at each meeting. Therefore, other approaches to reach parents, such as surveys and home visits, will be done.
- 2. There was approximately 60 percent attendance at last week's Parent-Teacher Conferences, which is down from last spring. Each school has a plan to follow up with the parents who did not attend.
- 3. The ASBA Region 7 Meeting will be held tomorrow night at Rivercrest High School at 6:00 p.m. Since the kickoff for the College Preparatory Academy for the Delta is also tomorrow

night, Board members agreed to meet at Arkansas Northeastern College and to go from there to the regional meeting.

- 4. Tools for Parents will be held Tuesday, October 25, from 6:00 to 7:00 p.m. in the administrative offices. Teryn Spears will work with parents on Home Access and other on-line activities.
- 5. Subs with the Superintendent will be held on Wednesday, October 26, at noon at Downtown Deli and Café. Blytheville City Council members have been invited to attend.
- 6. Cleaner, Safer Blytheville will host another work day on Saturday, October 29, 2011, from 8:00 a.m. to noon.
- 7. The district supports the IGNITE program, which helps families. Facility and staff may donate \$18, which will help feed a family and purchase toys for Christmas.
- 8. Mississippi County Superintendents meet the third Thursday of each month to discuss issues common with the students in the county.
- 9. This year's official October 1 count was 2797, which is down 130 students from last year's count.
- 10. The Board was given information on a fundraiser for the Chickasaw Band. Superintendent Atwill asked Board members to consider the band parents' proposal to sell advertisements to be placed on signs at Haley Field.

B. Report to the Public

1. Sandy Hughey, Assistant Superintendent

The district's primary academic focus is in literacy and math with reading, writing, and comprehension strategies being emphasized in all content areas. Four priorities have been set for this year—improving student performance, improving student attendance, improving student behavior, and increasing graduation rate. Information regarding goals, academic progress, AYP status, district accreditation, federal allocations, special needs funding, the Challenge Program, the competitive beverage contract, body mass index, and wellness, was shared with the Board. Board member training hours for January 1–December 31, 2010, were reported in accordance with Ark. Code Ann. §6-13-629.

2. Letroy Gathen, Executive Director of Support Services

The goal of the Title I program is "No Child Left Behind." This year's estimated budget is \$3,297,702. The program supports administrative costs, the parent/teacher center, five support staff, 49 paraprofessionals, two teachers, one math coach, and the preschool program. The program also supports various activities and staff development, as well as other district programs.

C. Instructional Reports

Sally Cooke, Curriculum Coordinator

Curriculum is being aligned to make a smoother transition for students moving to the next grade by having principals and instructional facilitators do peer visits in adjoining buildings.
