

## BOARD OF EDUCATION MINUTES

Hope Board of Education

September 22, 2008

The Hope Board of Education met in regular session on Monday, September 22, 2008, with President Joe Short presiding. The following members were present: Alvis Conway, Virginia Cully, Dora Philyaw, Mike Beasley, Denny Dickinson, and Danny Watson.

On a motion by Alvis Conway with a second by Dora Philyaw, the board voted to close nominations and reelect Joe Short as president. Motion carried unanimously.

On a motion by Joe Short with a second by Denny Dickinson, the board voted to reelect Alvis Conway as vice-president, Danny Watson as secretary, and Viney Johnson as financial board designee on a 7-0 vote.
