Hope Board of Education

March 15, 2010

The Hope Board of Education met on Monday, March 15, 2010, with President Joe Short presiding. The following members were present: Virginia Cully, Viney Johnson, Dora Philyaw, Mike Beasley, Jesus Coronado, Denny Dickinson, and Danny Watson.
