

BOARD OF EDUCATION
Hope Board of Education
August 16, 2010

The Hope Board of Education met in regular session on Monday, August 16, 2010, with President Joe Short presiding. The following members were present: Viney Johnson, Dora Philyaw, Mike Beasley, Jesus Coronado, Denny Dickinson and Danny Watson.

The minutes of the July 12th and July 19th meetings were approved on a motion by Danny Watson with a second by Dora Philyaw. Motion carried 7-0.

The July expenditures were approved on a motion by Viney Johnson with a second by Mike Beasley. Motion carried 7-0.

The facilities lease agreement for the CPS Cafetorium by Jim Paulson of the Boy Scouts of America was approved on a motion by Dora Philyaw with a second by Mike Beasley. Motion carried 7-0.

The board authorized the superintendent to enter into an agreement with America's Choice for services provided subject to the availability of adequate funding on a motion by Danny Watson with a second by Mike Beasley. Motion carried 7-0.

An employee grievance was held in open session per the employee's wishes. The employee, Janice McClellan, addressed the board with her request for compensation due to extra duties that have been assigned to her since the 2008-2009 school year and additional duties that were assigned to her for the 2009-2010 school year. A motion by Viney Johnson with a second by Dora Philyaw was made to compensate Mrs. McClellan for the extra duties mentioned. This motion failed on a 2-5 vote with Mike Beasley, Jesus Coronado, Denny Dickinson, Joe Short, and Danny Watson voting against.

After a closed session to discuss personnel, the following action was taken:

The board voted 7-0 to employ Samantha White and Stacy White as CPS teachers on a motion by Dora Philyaw with a second by Denny Dickinson.

Gregory Moore was employed as a Computer Technician with a .8 index on a motion by Danny Watson with a second by Viney Johnson. Motion carried 7-0.

Jesus Chavez was employed as a paraprofessional at Yerger Middle School on a motion by Jesus Coronado with a second by Denny Dickinson. Motion carried 7-0.

Beth Rowe was employed as a part-time Read Right Paraprofessional on a motion by Denny Dickinson with a second by Dora Philyaw. Motion carried 7-0.

The following were employed as custodians by a unanimous vote on a motion by Mike Beasley with a second by Jesus Coronado:

The board voted 7-0 to approve a one-time stipend of .05 to Terri Hoglund to administer the Carl Perkins Grant on a motion by Danny Watson with a second by Viney Johnson.
