4. INFORMATION ITEMS AND REPORTS

## A. Superintendent's Report

- 1. Due to the efforts of many, the district has ended the year \$344,000 ahead of last year. Fifty-four positions were saved.
- 2. The Board was shown a KAIT-8 news story about two Blytheville High School teachers who were convicted of inappropriate conduct with students. The incidents were acted upon quickly.
- 3. The Back-to-School Bash will be held on the grounds of Blytheville Elementary School on Sunday, August 18, from 4:00 6:00 p.m.
- 4. Principal Chanda Walker has completed Master Principal I through the Arkansas Leadership Academy. She is now working on requirements for Master Principal II. Requirements for completing the program are rigorous.

- 5. At the August meeting, Teryn Spears will speak about the Back-to-School Bash. Following the meeting, the Board will take a bus ride to showcase the projects done during the summer.
- 6. Beginning this year, all school office personnel will answer telephones in the same manner. They will state the name of the school, their name, and ask, "How may I help you."
- 7. A company is being sought to make a Chickasaw flag to hang below the Arkansas State Flag on district flag poles.
- 8. The district must establish a new baseline for Provision II. Applications will be collected this year.
- 9. Mr. Henton was honored at a reunion of teachers and students. The plaque presented to him was read to Board members.
- This year's JBHM/Generation Ready contract is in the amount of \$165,000, which is less previous years. Their services will meet the requirements of the State Department.
- 11. The pre-school professional development schedule will be sent to Board members when complete.

  - a. The summer session of the College Prep Academy went extremely well. Several comments made regarding the program were read to the Board.
  - b. The general session of the professional development will be held in the Blytheville High School Auditorium on August 12 at 10:30 a.m. Arkansas Teacher of the Year and BHS graduate, Ali Weimer, will speak.
  - c. New teacher orientation will be held on Friday, August 9 at 8:30 a.m. in the BHS Library. Lunch will be provided at 11:30 a.m. Teachers will visit the downtown area in the afternoon.
  - d. Blytheville Middle School was one of eight schools who received a National Best Practices Award from the JBHM consultants.
  - e. Preliminary scores for the literacy and math exams show increases. The official scores should be received in August.
