A. Superintendent's Report

- 1. There was no School Pride Recognition tonight due to Parent/Teacher Conferences.

1. Sally Cooke, Director of Curriculum

The district's goal is to achieve Annual Measurable Objective (AMO) in all schools in literacy and math. Priorities set for this year are improving student academic performance, improving student attendance, improving student behavior, and increasing graduation rate. Information regarding goals, academic progress, ESEA Waiver Status, district accreditation, graduation and attendance rate, federal allocations, special needs funding, the Challenge Program, the competitive beverage contract (Act 1220), body mass index, and wellness, was shared with with the Board. Board member training hours for January 1–December 31, 2012, were reported in accordance with Ark. Code Ann. §6-13-629.

2. Jean Cole, Director of Support Services

The goal of the Title I program is to improve student performance in literacy and math across the district.

This year's estimated budget is \$2,063,110.33. The program supports administrative costs, support staff, professional development, the parent/teacher center, paraprofessionals,

nurses, social worker, Generation Ready Consultants, and the preschool program. The program also supports various activities and other district programs.
