1. CALL TO ORDER

President Bennett called the meeting for the month of February

2014 to order.

2. ESTABLISHMENT OF A QUORUM

A quorum was established with six members present.

3. PLEDGE OF ALLEGIANCE

4. SCHOOL PRIDE RECOGNITION

Mike Wallace, Principal of Blytheville Middle School, introduced Band Director Ken Dumond, who spoke to the Board about this year's activities. Mr. Dumond introduced Assistant Band Director Melinda Williams, who directed six members of the eighthgrade band in three pieces of music.

5. INFORMATION ITEMS AND REPORTS

A. Superintendent's Report

- An email was recently sent to Board Members regarding a possible procedure for the graduation ceremony in the event of inclement weather. The Board took no action at this time.
- 2. The Arkansas State Board of Education has approved the Arkansas Department of Education Emergency Rules Governing Schools of Innovation. These rules will give districts some latitude on how students are educated. The rules will be discussed at the district staff meeting on Wednesday morning.

- 3. The Parent/Teachers Associations at each school will be responsible for the soda vending machines. The PTA's will receive 100 percent of the profit.
- 4. The superintendent and Tobey Johnson will attend the NEARK Regional P-20 Town Hall Meeting tomorrow at Arkansas State University.
- 5. The Chamber of Commerce Banquet will be held on Monday, March 10, at Arkansas Northeastern College at 6:30 p.m. Four of the district's teachers have been nominated for Teacher of the Year.
- 6. The NEARK School Boards Dinner will be held on Tuesday, March 18, at Arkansas State University from 6:00 p.m. to 8:00 p.m. NSBA President, Mr. David Picker, will be the speaker.
- 7. A decision on opting out of School Choice for the 2014-2015 school year must be made at regular Board meeting on March 17.
- 8. On a survey of the staff, a majority of those responding wished to take Friday, April 18, as a holiday and use June 3 as a make-up day.
- 9. The district received a letter today approving the budget for this school year.

B. Instructional Reports

- 1. Sally Cooke, Director of Curriculum
- a. On Wednesday, the district is having an on-site monitoring visit from the Arkansas Department of Education Department of Career and Technical Education.
- Sally Cooke and Kara Eagle will attend a career fair in Russellville on Thursday and one in Conway on Friday of this week.
- c. Each school staff nominated teachers for Teacher of Year for the Chamber of Commerce Banquet on March 10. The nominees are Robin Sneed, BHS, LaDonna Hester, BMS, Carlecia Gentry, BES, and Tracy Plunkett, BPS.
- d. Arkansas Northeastern College will host counselors and administrators in March for a visit to the tech center. It is hoped that more students will take advantage of both Technical classes and concurrent credit.
- e. The AdvancEd Accreditation visit will take place on April 27 to April 30. Parents, teachers, and 6-12 grade students are completing surveys prior to the visit. The Board will be

interviewed on April 28. On April 30, a Board meeting will be held at 2:00 p.m. as the exit interview.

- f. Professional development has already been scheduled at Crowley's Ridge Cooperative for teachers for the 2014-2015 school year. The professional development will be written in the teachers' growth plans.
- g. The Odyssey of the Mind competition will be held on Saturday, March 1, in Pocahontas. The district has great teams this year under the direction of Diane Hay.
- h. Tommy Bennett asked about the loss of MacBooks. Five have been stolen and five have been recovered due to technology in place. When a MacBook is opened, it tells where it is located and takes a photo of the person. Students and teachers are doing a great job keeping up with them.
- i. Tracey Ritchey told the Board about a program the Chamber of Commerce is hosting, "A Day in the Life..." It will be held on Wednesday, February 26, at Blytheville Middle School. Professionals will speak to eighth-grade career classrooms regarding careers to help students make better decisions in the future.
