1. CALL TO ORDER

President Bennett called the meeting for the month of June 2014

5. RECOGNATION OF RETIREE

President Tommy Bennett presented flowers and a gift certificate to Lisa Stovall in appreciation of 23 years of service to the district.

4. INFORMATION ITEMS AND REPORTS

A. Superintendent's Report

- Health care was a hot topic at the recent Superintendents' Institute. There appears to be no relief in sight unless Governor Beebe calls a special legislative session.
- 2. The district was required to change trustees for bonds. The new trustee is First Community Bank in Batesville.
- 3. Board members were given a copy of an advertisement for the Blytheville School District that was published in The Jonesboro Sun in March.
- 4. Sally Cooke was in Little Rock today with Amanda Self, who has written and been awarded a grant for substance abuse prevention in the amount of \$15,000 for Blytheville Middle School Target Club. Lower grades will be included, also.
- 5. The district has received a grant for \$15,000 to pay administrative costs for nurses through the Safe and Healthy Schools Initiative.

- 6. Tiffany Snyder has been awarded a grant in the amount of \$39,000 for fresh veggies and fruit.
- 7. The district will receive more information regarding the measures that have already been put in place to deal with Academic Distress at BHS.
- 8. The Board discussed the Uniform Dress Code, but took no action.
- 9. Billy Fair asked the superintendent to look into the possibility of reinstating the ROTC program at Blytheville High School.
- 10. Due to a ruling on a lawsuit in another Arkansas school district, the district must drop the pre-k program, put the program under Crowley's Ridge Coop, or purchase liability insurance for the program.
- 11. Tommy Bennett asked the superintendent to look into drug testing students in extracurricular activities.
- 12. Gene Henton shared an article from the Jonesboro Sun regarding alternatives to expulsion.

B. Instructional Reports

- 1. Sally Cooke, Director of Curriculum
 - a. The Board was shown a PowerPoint presentation regarding next years' student handbooks.
 - b. Board members were given Benchmarks scores for Math and Literacy and a district profile. This is the last year that Benchmarks will be given. PARCC assessment will be given next year.
- 2. Jean Cole, Director of Support Services
 - a. Discipline policies and procedures are being reviewed and analyzed. A report will be given to the Board at the July meeting.

C. Operations Report

- 1. GCA submitted the low bid for cleaning services for next year, coming in at \$30,000 less than the others.
- 2. A wall will be removed at Blytheville High School.
- 3. A sidewalk was added and one repaired at Blytheville Primary School.

- 4. The playground equipment at the former Central Elementary School will be moved to Blytheville Elementary School.
- 5. A copier company has contacted the superintendent about providing services to the district in an attempt to go green.
- 6. Two used buses, with low mileage, have been purchased.
 The district's mechanics do an excellent job taking caring of the fleet.
