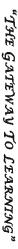

Below is an update pertaining to some of the issues I have been addressing since the previous Board meeting in March.

#### Legislative Capital Projects

The district's lobbyist is traveling to Juneau this week so an update on submitted projects will be provided during the Board meeting. In a conversation yesterday, there will probably be no capital discretionary funds available this year for any of the project submitted to the legislature.

#### FY16 Operation Budget Closeout

All administrators were notified that April 14, 2016 is the last day to submit purchase orders to spend regular instruction funds for FY16. Shortly thereafter, the business office will be able to provide an estimate of any remaining balances to carry forward. The CFO and myself met to analyze the FY16 Operating Budget that includes options to forward fund costs such as summer maintenance, fuel and other know expenses that can be paid in advance. A list of further suggestions and updates that affect the FY16 Budget will be provided to the Board at the April regular meeting. The Legislature is schedule to conclude on April 17<sup>th</sup> and then any decisions pertaining to the District's FY17 Operating Budget can be adjusted from pending legislative mandates. However, if the Legislature extends for further days, we may not have all the actual funding figures.

#### **AMP Testing**

The Department of Education and Early Development (DEED) canceled the Statewide AMP assessment because of a fiber optic line sliced during construction at the University of Kansas last week. Below is a part of DEED's news release:

"JUNEAU – Concerned that repeated technical disruptions to computer-based testing this week have rendered the affected tests invalid, the Department of Education & Early Development canceled them for this school year. Canceled are: the Alaska Measures of Progress (AMP), which are assessments in English language arts and mathematics for students in grades 3-10; alternate assessments in those subjects and grades for students with severe cognitive disabilities; and science tests in grades 4, 8, and 10."

#### Alaska Gateway Education Support Personnel (AGESP) Negotiations

The CFO and myself met with the classified union's negotiation team for a second time to discuss the approximately nineteen articles opened within the agreement. The next negotiation meeting with AGESP will occur on April 20<sup>th</sup> at 4:30 PM.

#### Vacancies

At this time there are ten current vacancies and two filled position with five transfers confirmed. A FY17 Certified Staff Hire listing is included within the Board packet. This list will include all hired, transferred and vacant certified positions for the 2016-2017 school year. Finding and retaining

quality teachers has become much more difficult because of the cause and effect associated with the current national ranking for Alaska's educator salaries and quality of retirement benefits.

#### FY17 Academic Calendar

The 2016-2017 District Calendar was approved as an Action Item during the March Board meeting. Teachers are scheduled to begin work for the 2016-2017 school year on August 16<sup>th</sup>, which is the same Tuesday of the month as last year and allows the District to close school for FY17 on the Friday before the Memorial Day holiday. This academic calendar also provides for "Moose Days" in September as well as two weeks for the holiday break in December and a full week for Spring Break in March. The calendar has be emailed to all schools and posted on the District's website.

#### **Energy Savings**

For the month of March the electricity billing at Tok School was \$6,093 for 19,160 kilowatts. We sure wanted to break the \$5,000 barrier for a winter month but didn't quite make the goal. However, this is lowest billing ever for a winter month as well as the lowest total usage of kilowatts. Just for comparison, in March of 2012, without the turbine in operation, Tok School utilized 47,480 kilowatts totaling \$20,295.

#### Alaska Teacher Job Fair

The Alaska Teacher Job Fair took place the 17<sup>th</sup> thru 19<sup>th</sup> of March this year instead of a late March or mid April date. Two Board members, Lisa Conrad and Peter Talus, along with two district office staff members, Scott MacManus and Deb Sparks, as well as myself screened and interviewed candidates for two days. Of the four contracts that were offered, two elementary teachers accepted positions with the District.

#### **FY17 Teacher Contracts**

All certified teacher contracts offered for the 2016-2017 school year have been either been accepted or a letter of resignation submitted.

#### **Policy Manual**

Updated all areas of the policy manual recently approved by the Board and emailed the manual to all administrators and Board members as well as replacing the older version on the district's website.

#### **Interior Superintendent's Meeting**

Met with the superintendents from Delta, Denali, Fairbanks, Galena, Nenana, Yukon-Flats and Yukon-Koyukuk to discuss cost saving measures such as staffing, provider services, itinerates, professional development, calendars, bussing, maintenance, curriculum and fuel. One last meeting for the year is scheduled for early May.

Here are some of the items I have worked on in the past month;

As you are aware Juneau has a proposal to cut education funding, this proposal will definitely affect our District if the proposed increases are approved. The proposal is to increase district paid percentages for both TRS(Teacher Retirement Services) and PERS(Public Employee Retirement Services). A 6.44% increase for TRS (currently 12.56%) and a 2.5% increase for PERS (currently 22%) These two increases will add approximately \$228,016 to our FY17 budget. It is hard to make decisions when we don't know for sure what is going to happen. I hope that you have written to our Representatives in the legislature to advocate for our District and let them know how these increases will hurt our District and all students in the State of Alaska with their proposals. Why should the School Districts take on this increase? We have already paid our portion into retirement. The State made the bad investing decisions and is now trying to pass their mistake on to the Districts. This is potentially catastrophic to School Districts.

The last few weeks have been busy looking at the current FY16 budget and seeing where we are sitting. After talking to our auditors, with Regional School Board approval we will transfer funds from the general fund into the "502" and use this money for summer maintenance. With the two years back pay from Impact Aid there are excess funds that we can use for this.

Todd and I went through the FY16 budget and made the annual revision, moving funds where they were needed. This revision is included in this report for your approval.

### **Current Projects**

- Evaluation and Curriculum We are continuing our work in getting our evaluation and curriculum system up and running. Next on the project is getting evaluation instruments for Classified staff, and for Certified Specialist positions.
- Strategic Planning I have been working with Eklund Consulting who is preparing to conduct a district-wide climate survey of staff that will take place in late April or early May. Eklund will work with the district leadership this spring, as we plan our approach and focus for next year to strategic planning
- o **Summer Curriculum Work** We are setting up for our summer curriculum work, which this year we will be on Science Curriculum.
- o **Indian Education Grant Applications Title VII -** We are in the middle of our annual Indian Education Application, and will have it completed by the end of this month.
- O Grants It is grant writing season, and we have a number of projects that we are planning out and working on a presentation model. Math in a Cultural Context is one of the project that we are looking at, as well as the Food Security application once it is released.
- o **Power of Food Presentations** As a joint project between PEP and Farms to Schools we are bringing up Dr. Robert Dell'Amore with a program called 'Inspiring Healthy Kids through the POWER of FOOD!'. This is an innovative, award-winning nutrition education/culinary performance workshop helps teach students, parents, food service staff and educators about the nutritional benefits of increased fruit and vegetable consumption, and the importance and life-long memories of first time positive experiences with new, healthy and delicious fruit/vegetable combinations. Dr. Dell'Amore will be working with our Kitchen and Garden staff to help them be able to use the produce from the greenhouse in their kitchens.
- School Improvement Grant (SIG 1003g) Final approval for the SIG grants has been received, and that project has been implemented in Tetlin and Tanacross. These funds paid to bring to Anchorage for the RTi (Response to Instruction) conference, where we able to enjoy the 7.1 quake.
- o **Fit-4-Life-** The 2 year evaluation of our PEP project is complete, and we are working on rebudgeting for next year, and are working with our external evaluator right now in a district wide data collection process to ensure that we are compliant and able to continue to get our final years funding next year, and are eligible for reapplication once this project is completed
- o **NCLB** Work on the FY17 ESEA Application is underway and I will be attending a workshop in Anchorage this month on the new federal requirements of these title

General - Much of this month's time has been committed to hiring working out staffing for next year.

As we move through the 4<sup>th</sup> quarter of the 2015-2016 school year, the special education department remains busy. There have been many students transferring in and out of our department and we are adjusting to these changes. Special education teachers have been working hard to ensure that Individual Education Program requirements and spring due dates are met. We currently have 52 special education students, 7 gifted and talented students and 4 students in the intervention process.

### **Trainings:**

- Vivianne Huber, an autism specialist from SESA, is in the district this week and is offering onsite training in Northway, Tok and Mentasta.
- Special Education teachers participated in TIENET training on March 30, 2016, the new online special education data management system. Once the security training on April 12<sup>th</sup> is completed the program will be ready to go live.

### **Specialists:**

Several specialists who contract with our school district have conducted their required visits and have met with students and staff to cover services required in student IEP's.

- E-therapy continues to work well. There are 31 in our school district who have goals in the area of speech & language and are receiving services through E-therapy. This includes pre-school students in both Northway and Tok. We have E-therapy services 2.5 days per week.
- Deb Fortune, speech pathologist, will be in the district the week of April 25th.
- Chris McDonald, Occupational Therapist will be in the district the week of April 25th.
- Ruth Lyles, Physical Therapist, will be in the district the week of April 25<sup>th</sup>.
- Frank Satterwhite, Psychologist, will be in the district the week of April 18th.

### **Current Projects:**

- Candy Thurneau and myself are working with TIENET to make a smooth transition from our current data management program. Once we have completed the security groups and data entry teachers will be able to go live with this new system.
- The date for Child Find has been set for Thursday, April 28<sup>th</sup>. We will have visiting specialists on staff that day to evaluate children. We are working with TCC, public health, Headstart and local schools to ensure this is a successful event. See attached flyer.
- We were disappointed to learn that the interior transition camp hosted by SERCC for this spring was cancelled. AGSD was looking forward to taking several high school students to Fairbanks to participate.
- We are realizing that with the switchover to the new data management system a data merge will need to occur. We are looking into options of how that may look and have requested the district look into the possibility of hiring an individual or two to assist with this so we are ready to go next fall.
- AGSD is planning on working another year with all current related service providers. MOA's are being drafted and will be presented this month.
- Extended School Year services are being reviewed and plans are being made to provide summer services to student's who have IEP that require extended school year.

Alaska Gateway School District is conducting its annual Child Find activities. As we look toward next school year, we can make sure children who need services receive them. We are looking for children affected by one or more of the following issues:

- \* Autism \* Cognitive Impairment \* Deafness \* Deaf-Blindness \*Early Childhood Delay \* Emotional Disturbance \* Hearing Impairment \* Learning Disability
  - \* Multiple Disabilities \* Orthopedic Impairment \* Other Health Impairment

We need to locate and identify children, birth through age 21, suspected of needing specialized services. Once identified, the child can be evaluated as to whether (s)he is eligible for Special Education Services. This applies to children of highly mobile, migrant or homeless families.

The Maintenance Department in the month of March was busy going to the schools and doing the preventive work orders and the work orders coming in, working on the summer maintenance list, surplus list, custodial inventory and the custodial order.

I am still doing some research and looking to find a way to fix the water problem at Eagle School, the reverses osmosis machine that was sent up there didn't work.

I had the water analyzed and it shows that the water softener is not working, I am working with Rick at the school to figure out what is causing the problem, I am also working with the water softener company to service it this summer, I will try and get more information by the time of the board meeting.

I still have not received any information from Siemens for the Tok School security system or the locking door devices, I am hoping that I will get it before the board meeting.

# Technology Board Report April 2016

Applications for Telecommunications, Internet, and advanced firewall services for next year have been applied for through ERate. Contracts for the switches and battery backups through Category 2 funds are being finalized now, and will be applied for as soon as contracts are signed. Funding being requested through the ERate program for next year is in excess of 1.2 million dollars.

The district application for the Broadband Assistance Grant program has been submitted. If funded by the state this would bring in approximately \$80,000 for Internet at our smaller sites. It is currently not certain if this program will be funded fully, or at all by the state. It is a pretty big ticket item for us in that we use the \$80,000 from the state to leverage an additional \$720,000 through the ERate program. This grant has allowed us to bring our smaller sites up to Internet levels that are in line with what students in less rural areas have access to, and has made a significant difference in terms of digital access for our students. If this program is not funded again we will have to decide how much of the current bandwidth we can afford to keep.

The new Chromebooks approved by the board at the last meeting have been ordered. Tracie and I will have attended the Google for Education training before the board meeting.

Additionally, I am attending the Farm to School mandatory grantee meeting in Texas in conjunction with the Google training.

Tony Lee ordered a number of items for the hydroponics facility we are putting together through the Farm to School grant, and will be beginning putting that together soon. I'm very excited to see what we can do with that in terms of volume production year round. Tracie Weisz
Curriculum and Instruction Coordinator
Board Report for 4/18/2016 Meeting

- March 28 to April 8 was the window for the district's Spring Writing Assessment. Students from 1st through 12th grades wrote to 4 different prompts for each grade band. All student writing submitted to our raters and will be returned by early May in time for the talent show and the annual Spring District Writing Contest.
- April 1 and 2 we hosted a curriculum workshop taught by Lilly Goodman-Allwright. The curriculum is Fire in a Changing Climate and is full of lessons and activities for grades k-12. The workshop was sponsored by the Alaska Division of Forestry and the Alaska Natural Resources and Outdoor Education Association (ANROE). Five teacher from AGSD took part in the day and a half workshop for 1 UAA graduate credit. The cost was free, due to funding made possible by a partnership between ANROE and the USDA Forest Service. Teachers attending reported that the workshop was very worthwhile and all plan to utilize the curriculum in their classrooms this spring.
- I created a new recruiting video for the March 18-20 Job Fair in Anchorage. The video is currently posted on the district website and can be viewed by clicking the button "Work at AGSD" on the front page. As of the date of this report it has received 80 views. It's a 5 minute video featuring demographic data and schools information, as well as a peek at the lifestyle and cultural aspects of living and working in our unique part of Alaska. It features footage of our area and schools, as well as interviews with various district staff. It is the first time we have ever utilized a recruiting video, and plans are already underway for how to improve upon this effort for next year.
- On April 7-9, I attended the Google Apps for Education (GAFE) Summit in Windsor, CA with Jason Fastenau. The first day was a special Google Authorized Bootcamp for people working toward Google Trainer certification (me). The session included an interactive overview, top tips from the Google Educator Training Center, hands-on activities, and inspiring ideas for how to use Google for teaching, learning, and professional collaboration. Following the Friday Bootcamp was the two day GAFE Summit. This two-day high-intensity event focused on deploying, integrating, and using Google Apps for Education (and other Google tools) to promote student learning. At the beginning of the 2015/2016 school year, AGSD obtained our Google.edu domain. Since then we have devoted time at each staff inservice for teacher training in Google Apps in the classroom. The training we received at the GAFE Summit not only keeps us current and up-to-date in this training, but allows us to bring current best practices for integrating technology in the classroom back to our teachers.
- As online teaching and learning becomes more mainstream, I have been exploring ways for AGSD to manage what we are already doing in this area and create a uniform platform for us to begin to build on. We currently contract with an online course provider, Odysseyware, for their package of online courses. In addition to that, we also offer our own online course to AGSD students in technology, and an online course to AGSD teachers in the AGSD Writing Program. We are also developing our own courses for students in Senior Survey (Life and Career Readiness), Alaska Studies, and an Online Course Readiness Survey, as well as several further online professional development courses for AGSD teachers. For the immediate future, these courses will be housed and delivered on Wikispaces. However, I am beginning to explore the feasibility and affordability of a learning management system (LMS) such as Blackboard or Canvas for us to use in the future, should we choose to grow further in this direction.

Other work this month has included support for various district teachers in classroom practice, classroom technology integration support, assisting with LEP testing, and curriculum reviews for our PEP grant.

# The Gateway Greenhouse April 2016 Board Report

Summer maintenance requests were submitted last month, my list for the greenhouse included new greenhouse covering, molding issue in the greenhouse entryway, individualized timing for the watering system, and shortening of end caps on beds 1-9. Since submitting, I stumbled across some information that may help with the molding issue in the entryway. I am planning to address that issue myself when the outside temps remain above freezing through the night.

I mentioned in my last report that we were waiting for a rundown and recommendations from the soil sample test results. We are still waiting and that information will be reported on as soon as we get that information.

The natural light is increasing and so is growth in the greenhouse. I have red tomatoes on one of the bush variety plants, and there are tomatoes forming on the indeterminate plants as well. I have already harvested about 40 cucumbers, 15 pounds of leaf lettuce mix, a few pounds of spinach, and even a zucchini. I will start harvesting green beans and banana peppers in the next couple weeks too. The sugar peas are flowering, so it won't be too long before the harvesting of those can start as well.

Hoping to start the growing season pest free prompted us to freeze the greenhouse for a month, however our hopes were dashed when the presence of fungus gnats increased very quickly. The need to keep surface soil moist, for the germination process, provided ideal conditions for them to multiply. The issue is under control now, and I credit Gene Ford for giving me the information needed, that resurfaced at just the right time, to get a handle on that pest issue. Aphids have also already been detected. A plan to add diatomaceous earth to the soil in each bed is in the works. We believe this will aid in pest management issues.

I'm including some photos with this report. They were all taken April 6, 2016.

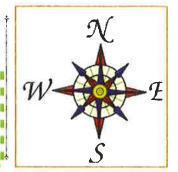

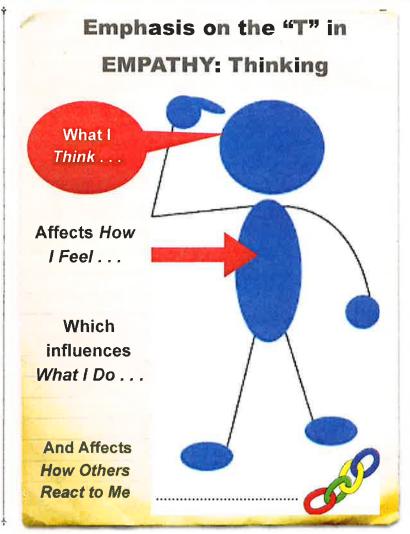

### Department of Education Cancels AMP and Other Computer-based Tests

JUNEAU – Concerned that repeated technical disruptions to computer-based testing this week have rendered the affected tests invalid, the Department of Education & Early Development canceled them for this school year.

Canceled are: the Alaska Measures of Progress (AMP), which are assessments in English language arts and mathematics for students in grades 3-10; alternate assessments in those subjects and grades for students with severe cognitive disabilities; and science tests in grades 4, 8, and 10.

The purpose of assessment is to provide valid, useful results. To have valid results, all students must be given the test under the same conditions. At this point, some students have been interrupted by online connectivity problems while they tested, in some cases repeatedly. We cannot with certainty say that this year's assessments will provide an accurate reflection of all students' knowledge and performance," said Dr. Susan McCauley, Interim Commissioner of Education & Early Development.

"I am not willing to keep Alaska's schools in this state of uncertainty given that we do not know if or when we can resume testing successfully," Dr. McCauley said. "We cannot allow students' learning to continue to be disrupted. Teachers need to know how to prepare their lessons for the week ahead. Superintendents and principals need to know how to arrange their schools' schedules and staffing."

Computer-based testing in Alaska was interrupted Tuesday when a construction worker accidentally severed a fiber optic cable at the University of Kansas. The university houses the state's testing vendor, the Achievement & Assessment Institute. Severing the cable cut the online connection between Alaska's test-takers and the vendor. When testing resumed on Thursday, Alaska schools experienced interruptions in the connection, and they reported that some students' answers had been lost.

Rosa Louise McCauley Parks was an African American civil rights activist. Congress called her "the first lady of civil rights" and "the mother of the freedom movement". Rosa was born February 4, 1913 in Tuskegee, Alabama. She died years later on October 24, 2005 in Detroit, Michigan. Rosa Parks is known for the Montgomery bus boycott. She started a bus boycott and fought to change the rules to equal rights on the buses and public facilities. It started when she boarded a city bus in Montgomery, Alabama. She sat down in a middle seat. Blacks were allowed to sit there as long as there were enough seats for the whites. A white man boarded the bus and there were not enough seats. Rosa was then asked to move so the white man could sit down but she refused. She was then instantly arrested. Rosa had to go to court to fight for the ability of blacks and whites to mutually use public facilities such as water fountains. restrooms and buses. Today we can all use public facilities without being separated and we have the right to do so. Therefore Rosa Parks changed history by not giving up that seat and starting a boycott which helped make things the way they are today.

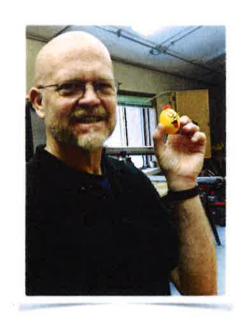

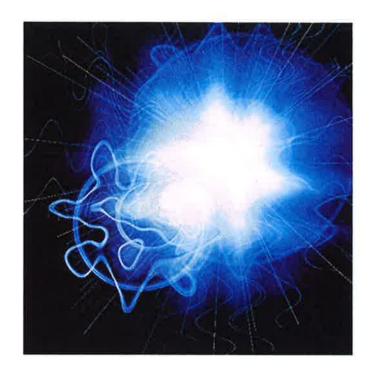
Though it took days for the dye to wear off of their hands, everyone had fun and even the teachers got into the action to enjoy the fun.

We are now taking our recess and other activities outside. We have done Village walks to remind people about the Lunch Bunch on Wednesdays. Our count for that activity last week was 21 people served and many satisfied customers with a great meal served by the students and staff of Dot Lake School.



We are doing science fair projects and have broken into groups with each group having a mix of young and old to produce a cross section of science that will transcend grade levels. JUNEAU – Concerned that repeated technical disruptions to computer-based testing this week have rendered the affected tests invalid, the Department of Education & Early Development canceled them for this school year.

Canceled are: the Alaska Measures of Progress (AMP), which are assessments in English language arts and mathematics for students in grades 3-10; alternate assessments in those subjects and grades for students with severe cognitive disabilities; and science tests in grades 4, 8, and 10.

"The purpose of assessment is to provide valid, useful results. To have valid results, all students must be given the test under the same conditions. At this point, some students have been interrupted by online connectivity problems while they tested, in some cases repeatedly. We cannot with certainty say that this year's assessments will provide an accurate reflection of all students' knowledge and performance," said Dr. Susan McCauley, Interim Commissioner of Education & Early Development.

"I am not willing to keep Alaska's schools in this state of uncertainty given that we do not know if or when we can resume testing successfully," Dr. McCauley said. "We cannot allow students' learning to continue to be disrupted. Teachers need to know how to prepare their lessons for the week ahead. Superintendents and principals need to know how to arrange their schools' schedules and staffing."

Computer-based testing in Alaska was interrupted Tuesday when a construction worker accidentally severed a fiber optic cable at the University of Kansas. The university houses the state's testing vendor, the Achievement & Assessment Institute. Severing the cable cut the online connection between Alaska's test-takers and the vendor. When testing resumed on Thursday, Alaska schools experienced interruptions in the connection, and they reported that some students' answers had been lost.

"Statewide assessments are an important source of information about student achievement, but only when the results are valid," Dr. McCauley said.

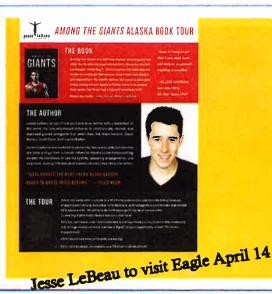

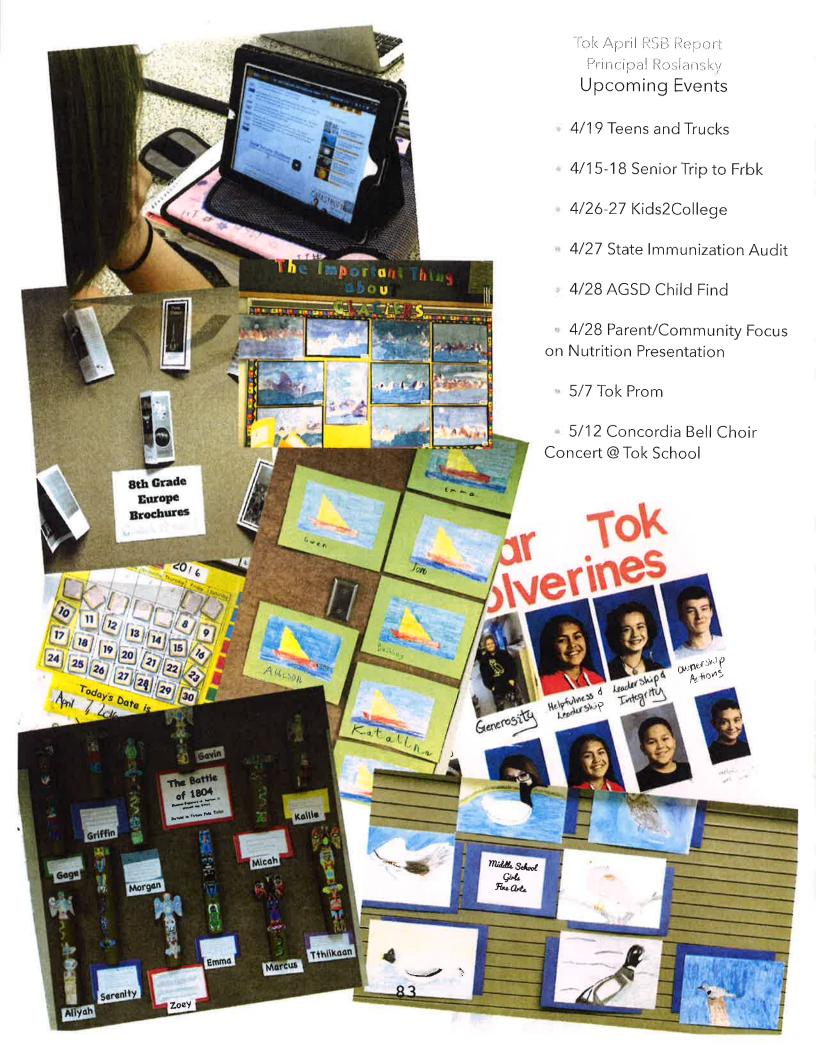
