# ARKADELPHIA BOARD OF EDUCATION Official Minutes March 17, 2015

The Arkadelphia Board of Education met in regular session Tuesday, March 17, 2015, at 6:00 p.m.in the Boardroom of the Administration Building, located at 235 North Eleventh Street.

**Members Present:** Dr. Jeff Root, President; Dr. Kenneth G. Harris, Jr., Vice President; Mr. Billy Groom, Mr. Randy Turner, Ms. Karrie Goodman.and Dr. Casey Motl.

The President called the meeting to order and established a quorum with six (6) members present.

#### **APPROVAL OF MINUTES**

The minutes of the regular meeting of January 20, February 3, and March 3, 2014 were approved as presented.

#### **ELECTION OF BOARD SECRETARY**

A motion was made by Dr. Harris, seconded by Mr. Turner, and carried 6-0 to elect Karrie Goodman for the position of Board Secretary to replace Ms. Terri King.

#### **INSTRUCTIONAL REPORT**

Dr. Donnie Whitten, Superintendent, introduced the principal and faculty members from Perritt Primary School for an instructional report to the Board. Technology & web-based student learning activities were presented by Principal Calley Hunley and teachers - Ms. Carrie Sharp, Ms. Trudy Conzel, and Ms. Dawn Forthman.

#### **FINANCIAL STATEMENTS**

The Board and Superintendent reviewed the District financial statements for January and February, 2015.

## **APPOINTMENT OF BUDGET COMMITTEE**

Dr. Harris nominated Mr. Randy Turner as recommendation for the Board representative on the district Budget Committee, 2015-16.

Upon the recommendation of the Superintendent, a motion was made by Dr. Harris, seconded by Ms. Goodman, and carried 6-0 to approve the proposed Budget Committee for 2015-16 composed of the following individuals: Board Member: Mr. Randy Turner; Dr. Donnie Whitten, Administration; Dr. Jeanette Turner, Administration; Ms. Nikki Thomas, Principal; Mr. Bud McMillion, Faculty; Ms. Glenda Williams, Classified staff.

#### PRESENTATION BY APPLE, INC.

A representative from APPLE, Inc. presented information regarding a proposal for providing laptops for student computer programs .

#### **COMMUNICATIONS UPDATE**

Mr. Sean Ruggles, Director of Communications for the District, provided a summary of the District's various communication programs, including a new district web site design, that is providing continuing enhancement and updated information for the public. Information was presented about the District App and its components for providing assistance to the students, staff, and public.

## **POLICY REVIEW**

Upon the recommendation of the Superintendent, a motion was made by Dr. Harris, seconded by Mr. Turner, and carried 6-0 to suspend the rules for two readings of policy revision and to approve the following policy revisions:

#### **CONSIDERATION OF FIXED ASSET DELETION LIST FY14**

Upon the recommendation of the Superintendent, a motion was made by Dr. Motl, seconded by Ms. Goodman and carried 6-0 - with an amendment for the Board to receive information regarding the amount of funds received from the deletion of the items - to approve the listed fixed asset deletion list as presented for 2014.

## LAND PURCHASE DISCUSSION

Information was discussed by the Board regarding adjoining land (5.18 acres) to the High School property, for the purpose of acquiring area for future district building development. A motion was made by Dr. Harris, seconded by Dr. Motl, and carried 6-0 for the Board to empower the Superintendent and Board member Randy Turner to move forward with discussion and study of a proposal to consider purchase of the land.

#### **MISCELLANEOUS**

The Board and Superintendent discussed the issue of the District's make-up for days missed during recent inclement weather. Dr. Whitten explained the procedure for creating the school calendar based on certified staff input and voting, with the current adopted calendar indicating making up any inclement weather days at the end of the year. Mr. Bud McMillion, PPC chairman, reported on the certified staff process for input on the current issue of making up the days at the end of the calendar, which resulted in the last day of school for 2015 being June 10.

The Board retired to executive session at 8:07 p.m. for the purpose of discussing the board member vacancy.
